As Staff Council President, I have had the honor of leading Staff Council this past year.
 We have over 2,500 staff at UT Dallas, and I have done my best to increase our visibility across campus and open lines of communication. As President, my focus has been to ensure that the mission of Staff Council is carried out, addressing staff questions and suggestions, and being an advocate for our constituents. I have worked closely with the Executive Board to address staff concerns and developing resolutions; finding ways to

better represent and support all staff. Below are key responsibilities that I have completed over the past year.

- Revision of the administrative support role for Staff Council
- Representation of Staff Council at Academic Senate, providing a brief update at each meeting
- Staff Representative for the Handbook on Policy (HOP) Committee
- Maintained communication lines with the Office of the President
- Made recommendations to the Executive Board and managed project implementation and follow through
- Oversaw the work of the ad hoc committees
- Led all Staff Council general meetings and coordinated the invitation of guest speakers; developed PowerPoint presentations for meetings and sharing of documents for review
- Coordinated with the Office of the President and the Office of Communications for the CARE Awards video ceremony for fall 2020 winners

Vice President Debra Greszler

• The Vice President of Staff Council maintained attendance records for Staff Council and standing committee participation. In addition, they made the necessary appointments to committees in consultation with the Executive Board.

Staff Development Committee report by Fatema Syeda

- The 2020-2021 Staff Development Committee focused on providing multiple ways for constituents to benefit from professional development and staff appreciation. Our biggest events were the Thankfulness, Gratitude, and Wellness Initiative and Staff Council Professional Development and Networking Session. Both were well received by campus. We received 74 responses to the TGWI survey and 91 people attended our live Professional development session.
- Other events we discussed and will host in the upcoming years include:

- o Yoga Session
- Grab and Go appreciation event
- Benefits and Retirement in conjunction with the Benefits committee.

Communications Committee Report by Melanie O'Brien

- The Communications Committee suspended the publication of *The Solar Flare* newsletter and focused more on distributing information via digital communication channels, including Microsoft Teams and social media platforms.
- The Communications Committee created a UTD Staff Council Instagram account to share Staff Council updates and activities and engage a broader audience within the UTD community.
- The Communications Committee continued to publish *The Sun* quarterly newsletter, which focused on issues affecting UTD staff, highlighted and celebrated the accomplishments of UTD staff, and included Staff Council updates relevant to employees and the UTD community.
- The Communications Committee suggested establishing Staff Council District email
 addresses for the use of District representatives, to communicate with each other more
 effectively within Districts. These email addresses can also be used by constituents to
 contact their respective Staff Council Representative. The UTD Staff Council Executive
 Board was in agreement with this recommendation and Vice President Debra Greszler
 generated the new email addresses.

Benefits Committee Report by Jennifer Klunk


- The Benefits Committee continued the process of scoring staff scholarship applications, revising the application form to provide a new essay question for applicants, as well as the scholarship website.
- The Benefits Committee was tasked with developing a process for the Rick Dempsey Scholarship. The committee had many discussions about how to integrate into current scholarship processes, what criteria to use, and how to best promote this new scholarship to the campus community.
- The Benefits Committee had many discussions with our ex-officio HR representative Marita Yancey about retirement information. We saw materials updated for use in the retirement process and are still looking to collaborate with Staff Development and the Retiree Association on a retirement event.

Fundraising Committee by Joey White-Swift

While a number of things were considered early on, it became clear that anything that we attempted to do in person would not result in any reasonable outcome. Therefore, we looked at pivoting to items that could be done on Teams, but what ultimately won out was making a virtual cookbook, with the added advantage that 100% of the proceeds could then go to staff council. This process included planning, working with the communications committee to solicit

recipes campus wide, processing those responses, and formatting the cookbook (with color!). We will set up the cookbook to sell into the next year utilizing Raiser's Edge, so that the next committee can focus on what we expect will be more of the traditional in person fundraising events for staff council.
